

Monthly Board Meeting
PARTRIDGE TOWNSHIP
August 2, 2023

Chairman, Matt Klocke called the meeting to order at 7:04 p.m. Present were Matt Klocke, Scott Peterson, and Anne Stitt. Pledge of Allegiance was recited. Minutes of the last Board Meeting were approved as read. Matt asked if any objections/corrections, none being stated approved as read. Treasurer's report was read. Beginning balance \$157,668.68, receipts totaled \$1,774.19 and disbursements of \$24,800.88, for ending balance to \$134,641.99. Outstanding checks of \$1,648.45, so ending bank balance of \$136,290.44. Matt asked if any objections/corrections, none being stated approved as presented. Claims to be paid tonight are 7885 to 7888.

Old Business:


- Brad from Central Right of Way Services is done except the cedar trees by Dick Andermann's. He had equipment break down and is hoping to finish soon. He has completed the roadside mowing.
- Scott got a phone call from Herman Velsvaag, and the Clerk got a phone call from Cookie. They wanted to know when Elwell ditching would occur now that Central Right of Way cut down the trees. Robert's Excavating said they are tied up with a project that should be done in two weeks and then they will then be doing all their projects including that one in succession.
- Matt did speak with Gus at Robert's Excavating and he did state that their intention once their current projects are completed is to hit the Township's projects all together, those projects include Koland Road, culverts, ditching and getting everything finished up.
- Scott attended National Night Out, he said there was 50-60 people which seems less than they had in the past. He did not see signage about the Donations/sponsors but he did not look at the prize table.
- Clerk spoke with City of Askov Clerk, Kathy, and was told that Sandy Gebhart, Public Safety Officer would be attending our next meeting in September. Kathy also put it on their agenda to remind Sandy one final time.
- Discussion was held on the Nuisance Ordinance, the Supervisors present felt that there was no need to table the passage, they chose to follow the Attorney's advice and adopt it in it's entirety, and then if things come up that threaten health or safety the Township has the Ordinance in place, it can be changed going forward if needed. Scott made a motion to adopt the Nuisance Ordinance as presented, Matt made a second. Motion carried 2-0.


New Business:
