

Monthly Board Meeting  
PARTRIDGE TOWNSHIP  
January 3, 2024

Chairman, Matt Klocke called the meeting to order at 7:00 p.m. Present were Matt Klocke, Scott Peterson, David Durheim, Laurie Jorgensen and Anne Stitt. Pledge of Allegiance was recited. Minutes of the last Board Meeting read. Matt asked if any objections/corrections, Laurie said that after the last meeting when she got home she located claim 7894 that clerk had asked about and it will be used tonight, minutes approved as read with the note added from the Treasurer. Treasurer's report was read. Beginning balance \$97,123.13, receipts totaled \$20,869.52 and disbursements of \$38,054.21 for ending balance to \$79,938.44. Current CD balance is \$206,043.42. A transfer was made from Zoning fund to Road and Bridge of \$16,379.02. Matt asked if any objections/corrections, none being stated approved as presented. Claims to be paid tonight ate 7894, 7907-7908.

Special Visitors:

- Scottie Gardonio of Daymark Designs attended via Zoom. She hopes to launch the new website mid Feb. Discussion was held about an elaborate spreadsheet to be able to have historical data on road maintenance. Multiple people can view, permissions can be easily set and then changed. She will send the design for the website and after that start working on this spreadsheet. The Clerk will find the spreadsheet Ovid Jensen had started and send that to Scottie.

- The State sent us the Project Worksheet on 12/20, Matt reviewed and signed it and it was returned to them the next day. Now we just have to wait for the reimbursement.


New Business:
