# Monthly Board Meeting PARTRIDGE TOWNSHIP May 1, 2024

## Special Visitors:

• Sheriff Jeff Nelson stated that this contract does not include extra patrol or anything like that. They can write citations after Zoning Letters have been sent and we have exhausted our options. It is basically to help enforcement of the Zoning Ordinance, the Supervisors stated they understood and would like to enter into the agreement with the Sherrif's office. Sheriff Nelson said they would send us a signed contract, then we should sign it and return with the copy of our current Zoning Ordinance. Scott made a motion to enter into the contract, David made a second. Motion carried 3-0.

### Old Business:

- Event permit application reviewed. Supervisors thought it was good to start with it and if things come up we can always be updated. Clerk will put on the website.
- Road inspection was completed prior to this meeting, gravel S side of Clark, North Pine and South Tamarack. Partridge Creek and Root Road South of curves will have blended gravel. Ditch E side of top of hill on Maple Hill Lane, and Fire Tower Road (Elwell Road). Build up Jackson Road by 33164 few loads to raise up about several inches.
- David is getting bolts and will start getting the Township signs up. Matt is going to call in locates for the posts we have to put in for some signs.

### **New Business:**

- Discussion held for combining Driveway permit and Land Use Permit. People might not know
  they need Driveway Permit if it is on Land Use Permit. Don't combine and look at Driveway
  Permit fee at next reorg, clerk will put it on the agenda.
- Draeger property on Root Road, next 30 days needs to meet with David for follow up, but she did call and spoke with David, just need to make sure progress keeps being made and follow up contact happens.
- Laurie asked that Kathy Bade get put on the agenda to come finalize the Historical Society handling the records we turned over for them to preserve.
